## Other services and activities that are not included in the contract or price list - are determined and priced individually, each time on the basis of a separate order.

#### **Billing rules:**

1. mKsięgość sp. z oo collects remuneration for each Settlement Period of the Agreement.

2. The remuneration is payable within 7 days of issuing the invoice. Payment is made by bank transfer to the mKsięgość sp. z oo bank account indicated on the VAT invoice. Failure to receive an invoice does not release the payment, which must be made by the 15th calendar day of the month.

3. The Price List is the basis for settling the Remuneration for Services.

4. The price list or individual valuation determined at the time of receiving the Order from the Customer is the basis for settling the Remuneration for the provision of Additional Services. mKsięgość sp. z oo may make the performance of a specific activity or the preparation of a document dependent on the payment of an advance payment in the amount specified by mKsięgość sp. z oo

5. The remuneration for the provision of the Additional Service is payable by the 15th (fifteenth) day of each month following the Settlement Period to which it relates, unless otherwise stipulated in the regulations for the provision of the Additional Service or a one-off Order. The remuneration is paid by bank transfer to the mKsięgość sp. z oo bank account indicated on the VAT invoice. A different form of settlement is possible, it determines the nature of the services.

6. The Customer shall bear all additional costs related to the provision of the Basic Services or Additional Services, including in particular the costs of additional fees, the costs of official, tax and court fees, e.g. such as the costs of the registration fee for the purposes of VAT, the costs of stamp duty, from the first power of attorney granted by the Client to a representative of mKsięgość sp. z oo

7. All amounts given in the Price List and relevant regulations for the provision of Additional Services are net amounts. These amounts do not include VAT due.

8. The Customer agrees and accepts the fact that all VAT invoices issued by mKsięgość sp. z oo related to the provision of Services will be sent to the Customer by e-mail to the e-mail address indicated by the Customer for correspondence.

9. In a situation where the Customer has suspended business activity, the monthly Remuneration due to mKsięgość sp. z oo is the amount indicated in the Price List, regardless of the Subscription chosen by the Customer.

10. In a situation where the Customer has suspended business activity, the Remuneration is calculated starting from the Settlement Period immediately following the delivery by the Customer to mKsięgość sp. z oo in written or electronic form of one of the following documents:

- a copy of the notification of suspension of economic activity submitted to the Central Registration and Information on Economic Activity
- a copy of the registry court's decision on the entry of the suspension of the commercial law company's operations.

11. The Client is obliged to pay mKsięgość sp. z oo the Remuneration in the full amount resulting from the selected Subscription option for each full month of suspension of activity until the notification or decision of the registry court is delivered.

12. The Client is not released from the obligation to pay the Remuneration to mKsięgość sp. z oo if he does not receive a VAT invoice issued by mKsięgość sp. z oo for the Remuneration for the provision of Services within the time limit indicated in point 2 above. In a situation where the Customer, in the case described in the previous sentence, pays an amount lower than the amount of the Remuneration specified on the VAT invoice issued by mKsięgość sp. z oo, he is obliged to immediately pay the difference between the amount indicated on the VAT invoice and the amount of actually paid Remuneration.

13. In a situation where the Client fails to pay mKsięgość sp. z oo the Remuneration within the time limit specified in point 2 above, he is obliged to pay mKsięgość sp. z oo, in addition to the principal amount, statutory interest for each day of delay.

14. Each payment made by the Customer will first be credited against the most recently due debt, and then against the established interest on the due receivables, regardless of the payment title indicated in the transfer.

15. In order to enable mutual settlements, the Customer authorizes mKsięgość sp. z oo to make deductions under any legal title between him and mKsięgość sp. z oo in order to make payments under the Agreement and the General Terms and Conditions of the Agreement.

16. mKsięgowisko sp. z oo is entitled to carry out activities related to telephone reminders, monitoring via e-mails, monitoring via SMS messages, sending reminders and requests for payment. The frequency of these activities depends on the customer's attitude - e-mails, text messages are generated first, then telephone calls, written reminders and a request for payment. Fees for individual debt collection activities are included in the Price List.

17. In a situation where the Customer delivers documents (in whole or in part) with a delay in relation to the deadline specified in the General Terms and Conditions of the Agreement, mKsięgość sp. z oo will charge a fee specified in the Price List.

18. The Customer is obliged to pay mKsięgość sp. z oo remuneration for all Services provided by mKsięgość sp. z oo, also after the date of termination or expiration of the Agreement, within 15 (fifteen) days from the date of issuing a VAT invoice by mKsięgość sp. z o. o.
